Citizen will fill the required details in the form and submit Citizen will receive a text message of the representation ID on the registered mobile number


A text message will be received by the concerned official about the addition of representation


Official can access the application from the iPGRS portal through Department User Login


After completing the representation process, Official will fill the ATR on the platform

Petition Submission process Citizen Flow




